As part of the merger which closed on July 21, 2006, a certain portion of our Preferred Stock was converted into 13,492,349 shares of Alteon common stock, a certain portion of our Preferred Stock was transferred to HaptoGuard, Inc. and our remaining Preferred Stock was canceled.
