- The securities represent deferred shares of the issuer's common stock credited to the reporting person's deferred compensation account pursuant to dividend equivalent rights. Those rights resulted initially in the addition of cash sums to the account equal to the dividends which would have been paid during the 2008 calendar year on the deferred stock credited to such account had that stock actually been issued and outstanding on each dividend payment date, and the accumulated sums were then converted into additional shares of deferred stock on January 2, 2009 based on the average of the closing selling prices of the issuer's common stock on each of the dates during the 2008 calendar year on which actual dividends on the common stock were paid.
- (1) 814 shares of deferred stock will be issued as fully vested shares of the issuer's Common Stock on January 5, 2009 and 2,119 shares of deferred stock will be distributed as actual shares of the issuer's Common Stock at a specified time (following termination of service with the issuer).

The shares underlying those restricted stock units and deferred stock may be subject in whole or in part to vesting schedules tied to the reporting person's continued service with the issuer or the attainment of performance goals and will be distributed as actual shares of the Issuer's Common Stock either at the time of vesting or at a specified time thereafter (including termination of service with the issuer). Please note that 2,886 shares of deferred stock will be distributed as actual shares of the issuer's Common Stock on January 5, 2009.
