(1) On July 28, 2010, The Toronto-Dominion Bank ("TD") contributed the equity of TD Discount Brokerage Holdings LLC (the "Reporting Person") to TD Luxembourg International Holdings Sarl ("TD Luxembourg") in exchange for equity in TD Luxembourg. Immediately following this contribution, the Reporting Person was dissolved, and the 193,300,000 shares of common stock of TD Ameritrade Holding Corporation previously held by the Reporting Person were held by TD Luxembourg.
