With respect to the VMTP Shares owned by Wells Fargo Bank, National Association ("WFBNA"), on May 19, 2015, WFBNA assigned certain preferred class voting rights on the VMTP Shares to a voting trust (the "Voting Trust") created pursuant to the Voting Trust Agreement, dated May 19, 2015 among WFBNA, Lord Securities Corporation, as voting trustee (the "Voting Trustee") and Institutional Shareholder Services Inc. (the "Voting Consultant"). Voting

and consent rights on the VMTP Shares not assigned to the Voting Trust have been retained by WFBNA. The Voting Trust provides that with respect to voting or consent matters relating to the voting rights assigned to the Voting Trust, the Voting Consultant analyzes such voting or consent matters and makes a recommendation to the Voting Trustee on voting or consenting. The Voting Trustee is obligated to follow any such recommendations of the Voting Consultant when providing a vote or consent. WFBNA has the right to cause the Issuer to register the VMTP Shares pursuant to a Registration Rights Agreement, dated May 19, 2015 between the Issuer and WFBNA.

This 13G filing is submitted because the asset's CUSIP changed from 67062T886 to 67062T878 effective 05/19/2015. The 13G CIK for the asset did not change. Because this asset continues to be reportable, two amendments have been filed: one amendment for the former CUSIP (to report an exit from that CUSIP) and another amendment for the new CUSIP (to report the asset ownership continuation under that CUSIP).
