### **CVRD signs Memorandum of Understanding with POSCO**

Rio de Janeiro, September 30, 2004 Companhia Vale do Rio Doce (CVRD), the largest producer of iron ore and pellets in the world, and Pohang Steel Corporation (POSCO), the largest south Korean steelmaker, signed a Memorandum of Understanding for the development of pre-feasibility studies for the construction of an integrated slab plant in São Luis, Maranhão state.

If implemented, the plant will produce initially four million tons of steel slabs per year.

This initiative reiterates CVRD s strategy of promoting iron ore consumption, exports, revenues and employment through minority participations in steel projects in Brazil.
